THE AFFILIATE, THANKS TO VERY GENEROUS DONATIONS, ACHIEVED RECORD RESTORE SALES OF \$813,572, EXCEEDING PRIOR YEAR PERFORMANCE BY \$100,000 AND INCREASING NET REVENUE BY \$60,000. 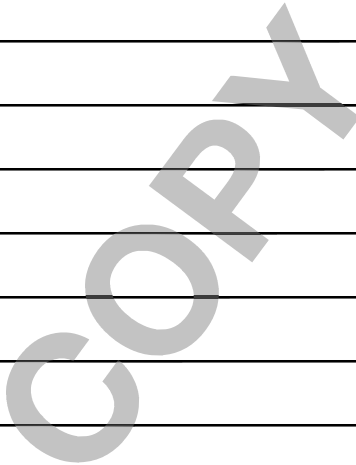
